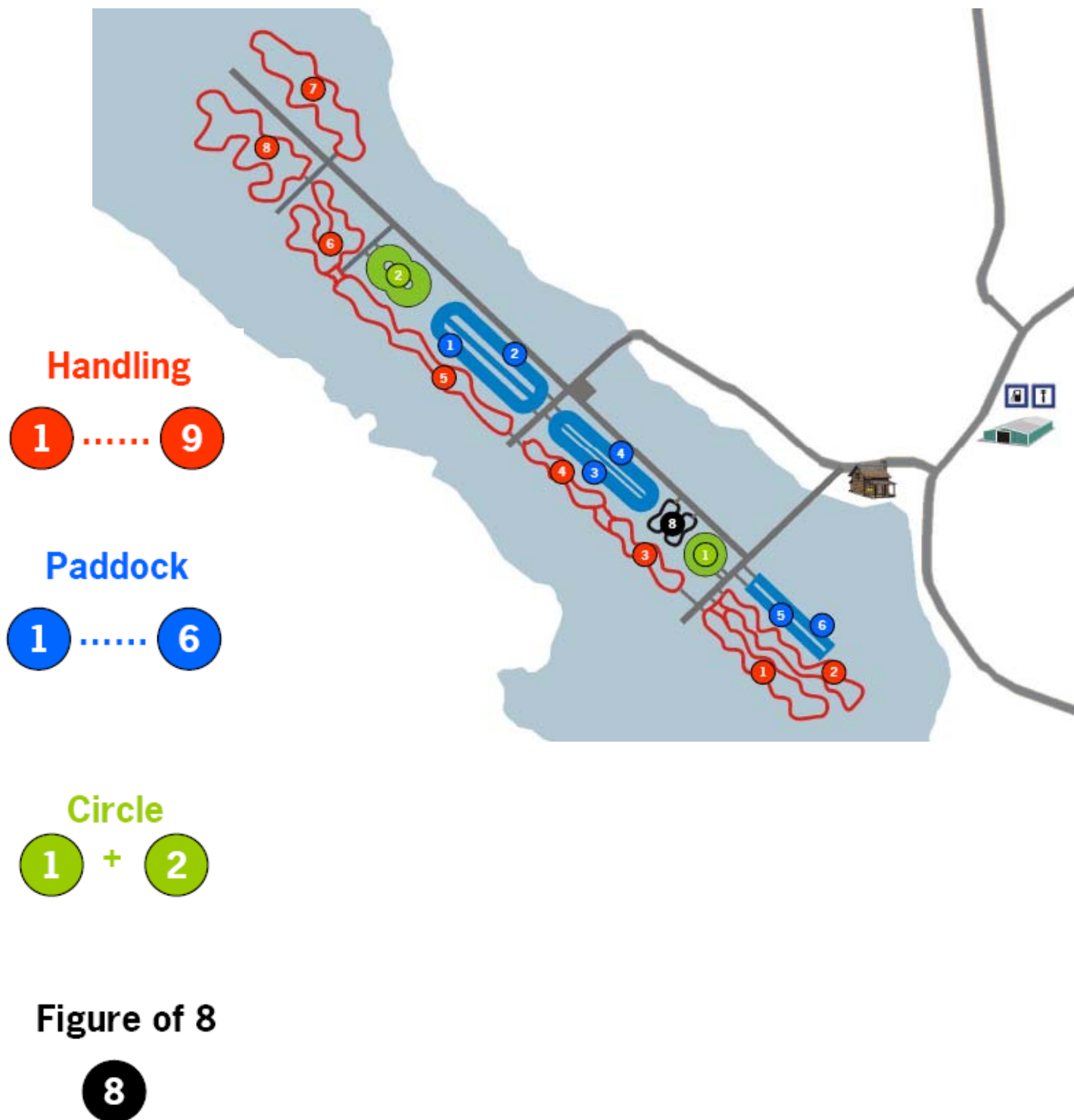

Transfer and arrival/departure

We would like to draw your attention to the announcements at the Helsinki airport during your stopover to be sure that you will not miss your flight to Ivalo. We ask you to choose your flight accordingly and **inform us via Email of the flight number and planned arrival time** to ensure that you will be welcomed by the Porsche staff, who will take you to the shuttle bus after your arrival to Ivalo.

Luggage tag

Please attach a luggage tag to each item of your luggage. The label must be clearly visible. This will enable us to take all luggage pieces to the hotel rooms without any delay.

Hand luggage

Please check with your airline concerning the hand luggage new regulations.

Passport / Visa / Driver's License /Credit Card

Please be sure to bring your valid driver's license and check that your passport is valid for another three months upon entering in Finland. Guests from EU member states only need a valid passport for entering the country, a visa is not required. Guests from other countries need a valid passport and should seek information as to the visa requirements for travel from their countries. Please make sure to have a valid identity card and/or passport as well as a valid driver's license and credit card with you.

Clothing

For Finland we recommend very warm clothing. Your luggage should definitely include the following: a warm winter jacket, a cap/hat, a scarf, gloves, sunglasses (also with yellow glasses if available), lip balm, warm socks, comfortable and warm outdoor shoes. Please dress in layers, as this facilitates the regulation of body regulation. For the evening events, we recommend smart casual attire. Bath robes are provided in your hotel room.

On the arrival day, you will receive the Porsche gift package, which includes a softshell jacket, a woolen hat and a backpack.

Vehicle Hire Contract for Porsche Driving Experience

I. Porsche provides the customer with the Porsche vehicle designated below:

II. The customer receives the vehicle on _____
The hire period is from _____ to _____

III. The vehicle will be provided for the customer to use himself / herself in the usual manner. The customer declares that he / she holds a valid driving licence. He / she is obligated to treat the vehicle correctly and with due care, to maintain it properly, and to drive it only if it is safe to operate.

IV. The vehicle is registered and covered by liability insurance in the name of Porsche. The liability insurance covers claims of up to € 7.5 million for personal injury per incident of harm; the coverage for property damage and economic loss is unlimited.

V. Comprehensive insurance is not provided. However, with regard to damage to the vehicle, the customer will be treated as if comprehensive insurance with an **excess of € 10,000.00** exists for the vehicle (subject to the provisions of **section VI**). Incidents of damage must be reported to Porsche without delay (use the Porsche Driving Experience damage report).

VI. From the time when the vehicle is collected to the time when it is returned, the customer shall be unrestrictedly liable with respect to Porsche for the destruction of the vehicle (including theft, pilferage, non-delivery and confiscation) and for all damage if the vehicle was destroyed or damaged due to gross negligence or intent on the part of the customer. If the vehicle is destroyed or damaged when being used for other than the agreed purpose, the customer shall be liable even in the event of simple negligence.

VII. Porsche shall not be liable – neither contractually nor extra-contractually – for any damage suffered by the customer or third parties in connection with provision of the vehicle. This disclaimer does not apply if Porsche is charged with gross negligence or intent, or if the customer or third parties suffer harm to life, limb or health. It furthermore does not apply if key contractual provisions are violated as a result of simple negligence. In such cases, however, liability shall be limited to compensation for the typical damage foreseeable at the time of concluding the contract. Statutory claims based on the product liability law shall remain unaffected. Claims cannot be asserted against employees and agents of Porsche insofar as claims do not exist against Porsche itself. The customer shall release Porsche from claims by third parties to the extent that and for as long as the liability insurance of Porsche does not cover the damage. Cases in which the insurer must settle a claim, but can take recourse against the customer or a driver based on statutory provisions, shall not affect Porsche. The customer shall release Porsche from all claims arising from the violation of laws, ordinances or other regulations in connection with use of the vehicle by him / her or a third party. Porsche is authorised to make payments if a claim is made, and to take recourse against the customer.

VIII. Instructions issued by the Porsche representative must be followed.

IX. The following costs are invoiced to the customer for provision of the vehicle:

a) as outlined in the offer

b) under the following terms: _____

X. With his / her signature, the customer confirms that the vehicle is in proper condition upon collection.

XI. After the end of the period of hire, the vehicle shall be returned to Porsche at the place of collection or at an agreed return location. If the vehicle is not returned on time, the customer is liable for any damage incurred by Porsche due to the withholding of its property.

XII. The place of fulfilment and jurisdiction is Stuttgart, unless a special place of jurisdiction is mandatory under law.

XIII. If you do not give us the consent below, the data you specify here will be used exclusively to process the hire contract. The data will not be passed along to third parties.

☐ **Declaration of consent:** I consent to having the data I specify here – except my banking data – stored in a central database administered under the responsibility of Porsche AG and merged with any other data from the Porsche Group. B) Exclusion of liability

Exclusion of liability Porsche Sport Driving School

To the benefit of Dr. Ing. h.c. F. Porsche AG, its directors, employees, staff, representatives and agents (hereinafter referred to as the beneficiaries), the signatory to this form declares the following with respect to participation in events organised by the Porsche Sport Driving School:

1. The signatory (participant) participates in the event at his own risk. He will bear all responsibility under civil and criminal law for any damage caused by him or to the vehicles he uses.
2. The signatory thus declares his agreement that the beneficiaries shall not bear any liability towards him for any personal injury, damage to property or financial loss, subject to the following restrictions: the exclusion of liability shall not apply if the beneficiaries are liable for gross negligence or malicious intent, or in case of injury to life, body or health. Likewise, it shall not apply if statutory compensation claims are asserted under default or impossibility for which the beneficiaries are responsible, nor shall it apply in the event of negligent violation of material contractual obligations; however, in such cases, liability shall be limited to compensation for the typical damages foreseeable at the time the contract was concluded. Claims under product liability law are unaffected.
3. Insofar as exclusion or limitation of liability has been agreed above, the signatory hereby agrees to this not only in his own name, but also on behalf of accompanying persons, helpers, any alternative vehicle owner and all natural or legal persons to which the claims in the event of an incident may pass.
4. Should the persons represented by the signatory not agree to this, he shall indemnify the beneficiaries for all claims that could be made against them under the invalidity of the above liability clauses.
5. The signatory shall indemnify the beneficiaries for all claims by third parties if these are made against the beneficiaries due to damage caused by the signatory.
6. We are aware that some insurers do not provide third-party or comprehensive insurance cover for vehicle damage that occurs during driving events of a competitive nature. This may leave you unable to claim for compensation against the party that has caused the damage or the insurer. We therefore recommend that you check the validity of your third-party accident insurance and, if applicable, your comprehensive insurance coverage with your car insurer. The organiser is unable to provide third-party or comprehensive accident insurance for participants.

Accompanying person: 1 person attending the event, but not taking part actively. The accompanying person may travel in a participant's car during section training. However, while the participant is completing laps, the accompanying person must travel with the instructor.

7. This agreement shall be governed by German law.
